Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, gem set, round pendant/enhancer, of hand-assembled construction.

Feature round domed pendant/enhancer, with central round button shaped cultured pearl, glue set. Surrounding is four bezel settings, at the cardinal points, each housing one round brilliant cut diamond, bezel set. The pendant/enhancer has been embellished with a granulation detail, and a texture to the front. The pendant/enhancer has been finished with an articulated hinged tapered bail, with a figure 8 safety clasp.

Pendant dimensions = 38.00mm (ave. length) x 24.52mm (ave. width) x 6.82mm (ave. depth).

Polished finish.

Stamped '750' - acid tested as 18 carat gold.

The pendant contains:

One glue set button shaped cultured pearl, colour is "white".

Dimensions = 8.78mm(Dia)

Four bezel set round brilliant cut diamonds, clarity is "Si", colour is "G to H" (mixed).

Dimensions (average) = 2.50mm(Dia) x 1.53mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.24ct (estimated - see NOTE below)

Total Item Weight = 7.16 grams

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pendant employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
