Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, flexible link necklet, of cast construction.

Feature central semi-round cultured pearl, glue set. The pendant has been finished with a white gold navette shaped bail, housing a total of thirty-six round brilliant cut diamonds, graduating in size, and claw set. The pendant has been suspended from a 'trace' style chain, that has been finished with a small lobster style clasp.

Chain dimensions = 45.50cm (ave. length) x 1.59mm (ave. width) x 1.60mm (ave. depth).

Pendant dimensions = 22.67mm (ave. length) x 2.99mm (ave. width) x 10.82mm (ave. depth)

Polished finish.

Stamped '750 unknown symbol PASPALLEY' - acid tested as 18 carat gold.

The necklet contains:

Thirty Six claw set round brilliant cut diamonds, clarity is "Vs", colour is "G".

Dimensions = 0.80mm(Dia) x 0.49mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.80mm(Dia) x 1.10mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.18ct (estimated - see NOTE below)

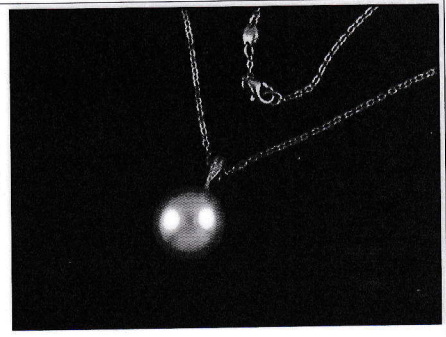
One end-drilled semi-round cultured white pearl, lustre is "Highest", blemish is "Almost blemish free", nacre thickness is "Very thick".

Dimensions = 15.52mm (ave. length) x 14.61mm (ave. width) x 14.55mm (ave. depth)

Total Item Weight = 8.84 grams

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar necklet employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
