Valuation for Traditional Retail Insurance Replacement

Item 1

One pair of, 18ct yellow gold, gem set, stud earrings, of hand-assembled construction.

Feature square bezel settings, each housing four square cut natural rubies, invisibly set. To the bottom of the setting, is one row of three round brilliant cut diamonds, bead set. The earrings are finished with post and butterfly attachments.

Earring dimensions = 9.74mm (ave. length) x 7.16mm (ave. width) x 4.63mm (ave. depth).

Polished finish.

Stamped '750 JE486' - acid tested as 18 carat gold.

The earrings contain:

Eight invisibly set square natural rubies, colour is "red".

Dimensions (average) = 3.00mm(L) x 3.00mm(W) x 2.12mm(D-estimated)

Total Weight = 1.44ct (estimated - see NOTE below)

Six bead set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions (average) = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.06ct (estimated - see NOTE below)

Total Item Weight = 5.60 grams Total Gemstone Weight = 1.50ct Total Metal Weight = 5.30 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
