## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 14ct white gold, multistone, gem set ring, of cast construction.

Plain, narrow, tapered band of 2.14mm in width (at base) x 1.24mm depth, with open back settings.

Feature single row spanning across the top of the plain and polished band, housing eight round brilliant cut diamonds, slightly tapering in size, in groups of two. Alternating with three baguette cut diamonds. All channel set.

Polished finish - stamped '14K A160 & unknown symbol' - acid tested as 14 carat gold. Finger size is N 1/2.

The ring contains:

Eight channel set round brilliant cut diamonds, clarity 'P1 & P2' (mixed), colour 'G to H' (mixed).  
Dimensions = 1.40mm(Dia) x 0.85mm(D-estimated) x 2%(Girdle Thickness) (smallest)  
Dimensions = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness) (largest)  
Total Weight = 0.11ct (estimated - see NOTE below)

Three channel set baguette cut diamonds, clarity 'P1 & P2' (mixed), colour 'G to H' (mixed).  
Dimensions (average) = 2.40mm(L) x 1.40mm(W) x 0.85mm(D-estimated) x 2%(Girdle Thickness)  
Total Weight = 0.09ct (estimated - see NOTE below)



Total Item Weight = 2.35 grams - Total Gemstone Weight = 0.20ct - Total Metal Weight = 2.31 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
