Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, gem set, multistone ring, of cast construction.

Plain, narrow, low half round band of 1.79mm width (at base) x 1.08mm depth, with a hollow top and shoulders.

Feature one row of four diamonds, alternating with three round natural sapphires, channel set. The settings are secured between the tapering shoulders, of the plain and polished band.

Polished finish.

Stamped '750 H diamond symbol B' - acid tested as 18 carat gold.

Ring size: M 1/2.

The ring contains:

Four channel set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions = 2.49mm(Dia) x 1.52mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.80mm(Dia) x 1.71mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.28ct (estimated - see NOTE below)

Three channel set round natural sapphires, colour is "blue".

Dimensions (average) = 2.75mm(Dia) x 1.68mm(D-estimated)

Total Weight = 0.27ct (estimated - see NOTE below)

Total Item Weight = 2.97 grams Total Gemstone Weight = 0.55ct Total Metal Weight = 2.86 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
