Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 18ct yellow gold and 18ct white gold, 'solitaire' design, diamond set ring.

Plain, narrow band of 1.57mm in width (at base) x 1.06mm depth, with open back setting.

Feature 'solitaire' style ring design, consisting of a white gold four claw setting, housing one round brilliant cut diamond, claw set. Secured between the extended 'ribbon' style shoulders of the yellow gold plain and polished band.

Polished finish.

Stamped 'FRSL LD 750' - acid tested as 18 carat gold. Hallmarked in London, England in 1960.

Finger size is H.

The ring contains:

One claw set round brilliant cut diamond, clarity 'Si', colour 'I'.

Dimensions = 4.28mm(L) x 4.26mm(W) x 2.60mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.30ct (estimated - see NOTE below)

Total Item Weight = 2.61 grams

Total Gemstone Weight = 0.30ct

Total Metal Weight = 2.55 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
