Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand finished raised, 18ct white gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 2.53mm width (at base) x 1.30mm depth, with curved underrail, open back settings underneath.

Feature, "illusion solitaire style" with shoulder stones. Comprising, a raised four claw setting to top, houses four Princess cut diamonds, grouped, illusion claw set. The extended shoulders, of the band tapers up to the top, each shoulder terminates with two tapered baguette cut diamonds end set, both sides.

Polished finish, stamped "7" - acid tested as 18 carat gold.

Finger size = H.

The ring contains;

Four illusion claw set Princess cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality.

Average dimensions = 2.40mm (L) x 2.40mm (W) x 1.70mm (D-estimated)

Total Weight = 0.30ct (estimated - see NOTE below).

Four end set tapered baguette diamonds, clarity is "Vs & Si"(mixed), colour is "H to I"(mixed), medium cut quality.

Average dimensions = 3.50mm (L) x 1.50mm (W) x 1.10mm (D-estimated)

Total Weight = 0.20ct (estimated - see NOTE below).

Total Item Weight = 3.88 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 3.78 grams, (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
