## Valuation For Traditional Insurance Replacement Purposes

### Item 1

One, 10ct yellow gold and rhodium plated, multistone, gem set ring.

Plain, wide, low half round, tapered band of 8.82mm at top to 3.70mm in width (at base) x 1.25mm depth, with hollow top and shoulders, and open back settings.

Feature multi-row design, spanning across the top of the plain and polished band, having fifteen round brilliant cut diamonds, channel set in the two central rows, and seventeen round brilliant cut diamonds, tapered in size from centre rows, bead set in the two outer rows. Rhodium plating to the settings, and having a multi-groove style design to each shoulder.

Polished finish.

Stamped '10K MHJ' - acid tested as approximately 10 carat gold.

Finger size is O.

The ring contains:

Sixty Four channel set & bead set (mixed) round brilliant cut diamonds, clarity 'P2 & P3' (mixed), colour 'H to J & brown tint' (mixed).

Dimensions = 1.30mm(Dia) x 0.73mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.80mm(Dia) x 1.05mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.75ct (estimated - see NOTE below)

Total Item Weight = 4.10 grams

Total Gemstone Weight = 0.75ct

Total Metal Weight = 3.95 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
