Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, gem set, pendant, of hand-assembled construction.

Feature 'infinity' style symbol shaped pendant, with a central four claw setting, housing one oval natural sapphire, claw set. Surrounding is twenty-two round brilliant cut diamonds, varying slightly in size, claw set. The pendant is finished with a hidden fixed bail.

Pendant dimensions = 19.28mm (ave. length) x 10.65mm (ave. width) x 6.51mm (ave. depth).

Polished finish.

Stamped '750' - acid tested as 18 carat gold.

The pendant contains:

One claw set oval shaped natural sapphire, colour is "blue".

Dimensions = 6.72mm(L) x 5.87mm(W) x 4.57mm(D-estimated) x 8%(Bulge)

Total Weight = 1.64ct (estimated - see NOTE below)

Twenty Two claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "G to H" (mixed).

Dimensions = 1.40mm - 1.50mm(Dia) x 0.85mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.31ct (estimated - see NOTE below)

Total Item Weight = 2.66 grams Total Gemstone Weight = 1.95ct Total Metal Weight = 2.27 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pendant employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
