Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 9ct yellow gold and 9ct white gold, 'solitaire' style, gem set ring.

Plain, narrow, tapered band of 1.49mm in width (at base) x 1.02mm depth, with hollow top and shoulders.

Feature central white gold six claw 'illusion' style setting, housing one round brilliant cut diamond, bead set. Secured between the yellow gold 'grooved ramp' style shoulders of the plain and polished band.

Polished finish.

Stamped '375 CG' - acid tested as 9 carat gold.

Finger size is R.

The ring contains:

One bead set round brilliant cut diamond, clarity "P2", colour "I".

Dimensions = 2.50mm(Dia) x 1.53mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.06ct (estimated - see NOTE below)

Total Item Weight = 1.48 grams

Total Gemstone Weight = 0.06ct

Total Metal Weight = 1.47 grams (estimated)

NOTE: There is a very fine crack at the base of the setting. Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
