Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, flat band of 4.92mm width (at base) x 1.05mm width, with a curved underrail.

Feature 'flower' style cluster design, with a central white gold illusion plate, housing one round brilliant cut diamond, illusion set. Surrounding is nineteen white gold four claw settings, each housing one round brilliant cut diamond, varying slightly in size, and claw set. The settings are embellished with six 'leaf' shaped decorative elements. All of the settings are secured to the underrail, and in between the tapering shoulders, of the plain and polished yellow gold band.

Polished finish.

Stamped '18CT' - acid tested as 18 carat gold.

Ring size: R 1/2.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Vs", colour is "H".

Dimensions = 3.50mm(Dia) x 2.14mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.16ct (estimated - see NOTE below)

Nineteen claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions = 2.00mm(Dia) x 1.22mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.20mm(Dia) x 1.34mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.67ct (estimated - see NOTE below)

Total Item Weight = 10.70 grams Total Gemstone Weight = 0.83ct Total Metal Weight = 10.53 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
