Valuation for Traditional Retail Insurance Replacement

One, 18ct white gold, gem set, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band of 3.04mm width (at base) x 1.26mm depth, with open back settings.

Feature central railed four claw setting, housing one Princess cut diamond, claw set. The setting is secured between the tapering shoulders, of the plain and polished band. Each of the shoulders houses one row of four Princess cut diamonds, slightly graduating in size, and channel set.



Polished finish. Incorrectly stamped '750 0.34' - acid tested as 18 carat gold. Ring size: I.

The ring contains:

One claw set Princess cut diamond, clarity is "Vs", colour is "G".

Dimensions = 3.80mm(L) x 3.25mm(W) x 2.31mm(D-estimated) x 5%(Girdle Thickness)

Total Weight = 0.21ct (estimated - see NOTE below)

Eight channel set Princess cut diamonds, clarity is "Vs", colour is "G".

Dimensions = 2.00mm(L) x 2.00mm(W) x 1.42mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.07mm(L) x 2.07mm(W) x 1.47mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.42ct (estimated - see NOTE below)

Total Item Weight = 5.14 grams Total Gemstone Weight = 0.63ct Total Metal Weight = 5.01 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
