Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, 'solitaire' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 1.74mm width (at base) x 0.96mm depth.

Feature central six claw setting, housing one round brilliant cut diamond, claw set. The setting is secured between the extended and pointed shoulders, of the plain and polished band.

Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Ring size: L 1/2.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Vs1", colour is "F".

Dimensions = 5.86mm(L) x 5.85mm(W) x 3.57mm(D-estimated) x 2.9%(Girdle Thickness)

Total Weight = 0.754ct (known weight - see NOTE below)

Total Item Weight = 2.07 grams

Total Gemstone Weight = 0.754ct

Total Metal Weight = 1.92 grams (estimated)

NOTE: The diamond has been certified by Messrs. Diamond Certification Laboratory of Australia, Certificate number: 111657. The diamond has also been laser inscribed upon the girdle with DCLA (logo) and DCLA 111657 H&A. Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
