Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.06mm width (at base) x 1.16mm depth, with open back settings, and a curved underrail.

Feature one curved row of five shared claws settings, each housing one round brilliant cut diamond, graduating in size, largest to the centre, and claw set. The settings are secured to the underrail, and in between the extended and pointed shoulders, of the plain and polished band.

Polished finish.

Stamped '750 TW' - acid tested as 18 carat gold.

Ring size: L.

The ring contains:

Five claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "light tinted brown" (mixed).

Dimensions = 2.66mm(Dia) x 1.62mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.23mm(Dia) x 1.97mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.61ct (estimated - see NOTE below)

Total Item Weight = 2.82 grams

Total Gemstone Weight = 0.61ct

Total Metal Weight = 2.70 grams (estimated)



NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
