## Valuation for Traditional Retail Insurance Replacement

## Item 1

One pair of hand-assembled, 18ct white gold, diamond set earrings.

Feature hinged 'hoop' style earring design, housing a total of seventy round brilliant cut diamonds, claw set to the outer front section, and inner back section.

Post fittings, with back arm locking mechanism attached.

Polished finish.

Stamped '750 MHJ 0.50' - acid tested as 18 carat gold.

Earring dimensions = 27.00mm (ave. diameter) x 1.72mm (ave. width) x 2.71mm (ave. depth).

The earrings contain:

Seventy claw set round brilliant cut diamonds, clarity 'P1 & P2' (mixed), colour 'G to H' (mixed).

Dimensions (average) = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 6.20 grams
Total Gemstone Weight = 1.00ct
Total Metal Weight = 6.00 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pair of earrings employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
