Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and platinum, gem set, 'three stone' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 1.54mm width (at base) x 0.93mm depth, with open back settings, and a curved underrail.

Feature 'vintage' style ring, with three platinum decorative six claw settings, spanning across the top of the band, graduating in size, largest to the centre. Each of the settings houses one round brilliant cut diamond, claw set. The settings are secured to the underrail, and in between the extended and pointed shoulders, of the plain and polished yellow gold band. The shoulders are embellished with 'strap' style detail.

Polished finish.

Stamped '18CT LAT' - acid tested as 18 carat gold and platinum.

Ring size: M.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si1", colour is "K".

Dimensions = 3.74mm(L) x 3.67mm(W) x 2.13mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.18ct (estimated - see NOTE below)

Two claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "I to J" (mixed).

Dimensions (average) = 2.85mm(Dia) x 1.74mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.17ct (estimated - see NOTE below)

Total Item Weight = 2.43 grams Total Gemstone Weight = 0.35ct Total Metal Weight = 2.36 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
