Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, gem set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round, tapered band of 2.79mm width (at base) x 1.32mm depth, with a hollow top and shoulders, open back settings, and a cut out curved underrail.

Feature cushion shaped top plate, housing eight round brilliant cut diamonds, claw set. Surrounding, is one row of twelve round brilliant cut diamonds, claw set. The top plate, is secured between the 'split' style shoulders, of the plain and polished band. The shoulders and rails are embellished with fifty round brilliant cut diamonds, varying in size, and claw set. Millegrain detail to the edges of the settings.

Polished finish.

Stamped '9K 1.00CT' - acid tested as 9 carat gold.

Ring size: Q.

The ring contains:

- Seventy One claw set round brilliant cut diamonds, clarity is "SI & P1 & P2 & P3" (mixed), colour is " H to I" (mixed).
- Dimensions = 1.02mm(Dia) x 0.62mm(D-estimated) x 2%(Girdle Thickness) (smallest)
- Dimensions = 1.90mm(Dia) x 1.16mm(D-estimated) x 2%(Girdle Thickness) (largest)
- Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 5.31 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 5.11 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
