One, platinum, gem set, 'solitaire' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 1.54mm width (at base) x 1.46mm depth, with a curved underrail.

Feature central four claw setting, housing one synthetic laboratory grown round brilliant cut diamond, claw set. The setting is secured to the underrail, and in between the extended and pointed shoulders, of the plain and polished band.



Polished finish.

Stamped 'NJ Pt950' - acid tested as platinum.

The ring contains:

One claw set synthetic laboratory grown round brilliant cut diamond, clarity is "Vs1", colour is "D".

Dimensions = 6.00mm(L) x 5.98mm(W) x 3.68mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.81ct (known weight - see NOTE below)

Total Item Weight = 3.68 grams Total Gemstone Weight = 0.81ct Total Metal Weight = 3.52 grams (estimated)

NOTE: The centre synthetic laboratory grown round brilliant cut diamond has been certified by and is the opinion of Messrs. International Gemological Institute, Certificate no. LG589304181 Dated July 10, 2023. The synthetic laboratory grown round brilliant cut diamond has also been laser inscribed upon the girdle with IGI (logo) and LG589304181. Due to setting constraints, the exact dimensions of the synthetic laboratory grown round brilliant cut diamond cannot be ascertained. Therefore, weight of the synthetic laboratory grown round brilliant cut diamond requires removal from the setting.
