## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 10ct white gold, gem set, multistone ring, of cast construction.

Plain, wide, low half round double band of 5.32mm width (at base) x 1.19mm depth, with a hollow top and shoulders, and open back settings.

Feature each of the four extended and pointed terminations, meet in the centre of the band. Each of the terminations houses four round brilliant cut diamonds, graduating in size and channel set. The settings are secured between the shoulders of the plain and polished band.



Polished finish.

Stamped '10K michael hill 0.25 TDW' - acid tested as 10 carat gold.

Ring size: N 1/2.

The ring contains:

Sixteen channel set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "H to I" (mixed).

Dimensions = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.90mm(Dia) x 1.16mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.25ct (estimated - see NOTE below)

Total Item Weight = 3.53 grams Total Gemstone Weight = 0.25ct

Total Metal Weight = 3.48 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
