One, 18ct white gold, gem set, 'solitaire' style ring, of cast construction.

Plain, narrow, low half round band of 1.98mm width (at base) x 1.00mm depth.

Feature central six claw setting, housing one round brilliant cut diamond, claw set. The setting is secured to the top of the extended and pointed shoulders, of the plain and polished band.

Polished finish.

Stamped '18K michael hill 45360900318' - acid tested as 18 carat gold.

Ring size: L.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P1", colour is "G".

Dimensions = 4.92mm(L) x 4.88mm(W) x 3.24mm(D-estimated) x 3.5%(Girdle Thickness)

Total Weight = 0.50ct (known weight - see NOTE below)

Total Item Weight = 2.59 grams

Total Gemstone Weight = 0.50ct

Total Metal Weight = 2.49 grams (estimated)

NOTE: The diamond has been authenticated by Messrs. Gemological Science International Report number: 45360900318. The diamond has also been laser inscribed upon the girdle with michael hill and 45360900318. Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
