### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, 18ct white gold, gem set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round band of 2.14mm width (at base) x 0.77mm depth, with open back settings, and a curved underrail.

Feature central eight claw setting, housing one round brilliant cut diamond, claw set. Surrounding is one row of ten round brilliant cut diamonds, claw set. Each of the shoulders are embellished with a group of three round brilliant cut diamonds, graduating in size, and claw set. The settings are secured to the underrail, and in between the extended and pointed shoulders, of the plain and polished band.

Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Ring size: J.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si1", colour is "I".

Dimensions = 4.00mm(Dia) x 2.26mm(D-estimated) x 2%(Girdle Thickness)  
Total Weight = 0.23ct (estimated - see NOTE below)

Sixteen claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions = 1.60mm(Dia) x 0.98mm(D-estimated) x 2%(Girdle Thickness) (smallest)  
Dimensions = 1.71mm(Dia) x 1.04mm(D-estimated) x 2%(Girdle Thickness) (largest)  
Total Weight = 0.27ct (estimated - see NOTE below)

Total Item Weight = 2.16 grams Total Gemstone Weight = 0.50ct Total Metal Weight = 2.06 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
