## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 14ct white gold, gem set, 'dress' style ring, of cast construction.

Plain, narrow, low half round band of 1.83mm width (at base) x 1.26mm depth, with open back settings, with a curved underrail.

Feature central four claw setting, housing one round natural tanzanite, claw set. Either side of the central setting, is one four claw setting, each housing one round brilliant cut diamond, claw set. The settings are secured between the extended and square shoulders, of the plain and polished band. Each of the shoulders houses one row of six round brilliant cut diamonds, claw set.



Polished finish.

Stamped '14K' - acid tested as 14 carat gold.

Ring size: L.

The ring contains:

One claw set round natural tanzanite, colour is "blue".

Dimensions = 5.89mm(L) x 5.86mm(W) x 4.44mm(D-estimated)

Total Weight = 1.00ct (estimated - see NOTE below)

Fourteen claw set round brilliant cut diamonds, clarity is "Si", colour is "H to I" (mixed).

Dimensions = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.19mm(Dia) x 1.95mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.36ct (estimated - see NOTE below)

Total Item Weight = 3.29 grams Total Gemstone Weight = 1.36ct Total Metal Weight = 3.02 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
