Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled raised, platinum & 18ct yellow gold, gemset, multistone ring. Plain, narrow, low half round, tapered band, measures 2.68mm width (at base) x 1.03mm depth, with open back.

Feature; "dress style" ring design. Comprising, a raised oval-shaped, rub-over setting to centre, houses one oval-shaped, faceted natural peridot, rub-over set. To each side, a heart-shaped setting of yellow gold, each contain three sigle cut diamonds (one chipped), bead set. The extended shoulders, of the band taper up with a rope style, termination feature to both sides.



Polished finish, stamped "Pt 900, K18, 232,003" - acid tested as platinum & 18 carat gold.

Finger size = M.

The ring contains;

One rub-over set oval-shaped natural peridot, colour is "medium yellowish/green".

Dimensions = 10.38mm (L) x 8.85mm (W) x 4.76mm (D-estimated)

Total Weight = 2.94ct (estimated - see NOTE below).

Six bead set single cut diamonds, clarity is "P1 & P2"(mixed), colour is "tint light brown", medium cut quality.

Dimensions = 0.93mm (average diameter)

Total Weight = 0.03ct (estimated - see NOTE below).

Total Item Weight = 7.32 grams, Total Gemstone Weight = 2.97ct, Total Metal Weight = 6.73 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
