Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 18ct white gold, multistone, gem set ring.

Plain, narrow, reverse tapered band of 1.90mm in width (at base) x 1.13mm in depth, with open back settings.

Feature 'two cluster cross-over' ring design. One cluster contains seven round brilliant cut diamonds, largest to centre, claw set. The opposing cluster houses seven round cut and faceted natural pink sapphires, largest to centre, also claw set. The clusters are separated by the 'cross-over ramp' style shoulders of the plain and polished band.

Polished finish.

Stamped '750 AW' - acid tested as 18 carat gold. Assayed in Birmingham, England. Finger size is L.

The ring contains:

Seven claw set round brilliant cut diamonds, clarity "P1 & P2" (mixed), colour "H".

Dimensions = 2.60mm(Dia) x 1.59mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.80mm(Dia) x 1.71mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.49ct (estimated - see NOTE below)

Seven claw set round cut natural sapphires, colour is "medium light pink".

Dimensions = 2.60mm(Dia) x 1.59mm(D-estimated) x 5%(Bulge) (smallest)

Dimensions = 2.95mm(Dia) x 1.80mm(D-estimated) x 5%(Bulge) (largest)

Total Weight = 0.56ct (estimated - see NOTE below)

Total Item Weight = 5.73 grams - Total Gemstone Weight = 1.05ct - Total Metal Weight = 5.52 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
