Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, gem set, 'dress' style ring, of cast construction.

Plain, wide, low half round band of 4.54mm width (at base) x 1.04mm depth, with an open back setting,

Feature central bezel setting, housing one round natural sapphire, bezel set. The setting is secured between the tapering shoulders, of the plain and polished band. Each of the shoulders is embellished with engraved 'scroll' style detail.

Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Ring size: U 1/2.

The ring contains:

One bezel set round natural sapphire, colour is "green".

Dimensions = 6.56mm(L) x 6.53mm(W) x 3.55mm(D-estimated) x 4%(Bulge)

Total Weight = 1.14ct (estimated - see NOTE below)

Total Item Weight = 6.12 grams

Total Gemstone Weight = 1.14ct

Total Metal Weight = 5.89 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
