A stamped 14K Michael Hill 0.65 TDW white gold seventy eight diamond and one laboratory grown diamond ring.

The large diamond is four claw set in the centre with diamonds four claw set in the surrounding halo.

Diamonds are four claw set along the split, cross over design shoulders.
