## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 18ct yellow gold and 18ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.30mm width (at base) x 0.90mm depth.

Feature 'flower' style cluster ring, with a white gold top plate, and a central six claw setting, housing one round brilliant cut diamond, claw set. Surrounding is a total of thirty-two claw settings, each housing one single cut diamond, graduating in size, and claw set. The settings are supported with an open wire base, and is secured to the top of the plain and polished yellow gold tapered band.

Polished finish.

Stamped '18CT' - acid tested as 18 carat gold.

Ring size: N 1/2.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Vs", colour is "H".

Dimensions = 3.70mm(L) x 3.68mm(W) x 2.24mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.18ct (estimated - see NOTE below)

Thirty Two claw set single cut diamonds, clarity is "Vs & Si" (mixed), colour is "H".

Dimensions = 1.20mm (diameter) (smallest)

Dimensions = 1.70mm (diameter) (largest)

Total Weight = 0.45ct (estimated - see NOTE below)

Total Item Weight = 5.61 grams Total Gemstone Weight = 0.63ct Total Metal Weight = 5.48 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
