Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and rhodium plated, multistone ring, of cast construction.

Plain, narrow, low half round band of 3.23mm width (at base) x 1.11mm depth, with open back settings.

Feature rectangle top plate, housing one row of five round brilliant cut diamonds, varying slightly in size, and channel set. The top plate is secured between the tapering shoulders, of the plain and polished yellow gold band. Rhodium plating to the diamond setting area.

Polished finish.

Stamped 'SK 9K' - acid tested as 9 carat gold.

Ring size: T 1/2.

The ring contains:

Five channel set round brilliant cut diamonds, clarity is "P1", colour is "H to I" (mixed).

Dimensions = 2.70mm(Dia) x 1.65mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.05mm(Dia) x 1.86mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.41ct (estimated - see NOTE below)

Total Item Weight = 8.23 grams

Total Gemstone Weight = 0.41ct

Total Metal Weight = 8.15 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
