Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled raised, 18ct yellow gold, platinum & diamond set, multistone ring.

Plain, narrow, low half round, tapered band, measures 1.60mm width (at base) x 1.00mm depth, with curved underrail, open back settings, underneath.

Feature; "single graduating row " style, runs across the top. Comprising, five rub-over platinum topped settings, tapering from the centre down, contains five Old European cut diamonds, rub-over set. The extended shoulders, up to pointed end terminations, to both sides.

Polished finish, stamped "18ct & Plat, HG&S" - acid tested. Finger size = P.

The ring contains;

Five rub-over set Old European cut diamonds, clarity is "Vs & Si"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 1.85mm (average diameter) x 1.20mm (D-estimated) (smallest)

Dimensions = 3.32mm (average diameter) x 1.89mm (D-estimated) (largest)

Total Weight = 0.28ct (estimated - see NOTE below).

Total Item Weight = 2.34 grams, Total Gemstone Weight = 0.28ct, Total Metal Weight = 2.28 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar ring. The below replacement figure is based upon crafting a similar ring using all modern round brilliant cut diamonds of the same estimated weight, colour and clarity employing similar materials and techniques being for a retail insurance purpose only.
