### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, hand finished raised, 18ct yellow gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 2.84mm width (at base) x 1.19mm depth, with curved underrail.

Feature: "solitaire style" ring design, with shoulder stones. Comprising, a raised v-claw setting to centre, houses one marquise cut diamond, v-claw set. The extended shoulders, of the band tapers up, splits to each side, with pointed end terminations. each shoulder contains six round brilliant cut diamonds, channel set.

Polished finish, stamped "MHJ 18K.50" - acid tetsed & x-rayed. Finger size = N1/2.

The ring contains;

One claw set marquise cut diamond, clarity is "P1", colour is "J", medium cut quality.  
Dimensions = 6.50mm (L) x 3.50mm (W) x 2.14mm (D-estimated)  
Total Weight = 0.28ct (estimated - see NOTE below).

Twelve channel set round brilliant cut diamonds, clarity is "Si", colour is "I to J"(mixed), medium cut quality.  
Dimensions = 1.60mm (average diameter) x 0.98mm (D-estimated) (smallest)  
Dimensions = 1.80mm (average diameter) x 1.10mm (D-estimated) (largest)  
Total Weight = 0.22ct (estimated - see NOTE below).

Total Item Weight = 4.74 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 4.64 grams (estimated)

NOTE: Limited gemmologival testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
