Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled raised, 18ct white gold & diamond set, hinged bangle.

Feature: "oval shaped, single row" style bangle. Comprising, a channel row across the top, open back settings underneath, houses thirty nine Princess cut diamonds, channel set. The bangle is plain to back, hinged to one side & having a tongue in box style closure, fitted to one side a figure 8 safety clip attached.

Polished finish, stamped "750, MHJ" - acid tested as 18 carat gold.

Bangle dimensions (inside) = 60.00mm (L) x 55.00mm (W).

Bangle cross-sectional dimensions = 2.28mm (width) x 1.62mm (depth).

The bangle contains:

Thirty Nine channel set Princess cut diamonds, clarity is "Si & P1" (mixed), colour is "H to I" (mixed), medium cut quality.
Average dimensions = 1.50mm (L) x 1.50mm (W) x 1.06mm (D-estimated) (smallest)
Average dimensions = 1.80mm (L) x 1.80mm (W) x 1.28mm (D-estimated) (largest)
Total Weight = 1.00ct (estimated - see NOTE below).

Total Item Weight = 11.27 grams, Total Gemstone Weight = 1.00ct, Total Metal Weight = 11.07 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar bangle employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
