## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, hand-assembled raised, 9ct yellow gold & gemset, flexible link bracelet.

Feature: "filigree style padlock" fancy linked bracelet. Comprising, a filigree heart-shaped padlock closure with a heart-shaped, faceted natural garnet to centre, claw set. The bracelet having a 3 in 1 figaro style links, running the length of the bracelet with a fine curb linked safety chain attached.

Polished finish, stamped "9ct" - acid tested as 9 carat gold.

Bracelet dimensions = 19.00cm (total length) x 5.41mm (width) x 2.58mm (depth).

Padlock clasp; dimensions = 20.27mm (length) x 14.74mm (width) x 7.59mm (depth).

The bracelet contains:

One claw set heart-shaped, faceted, natural garnet, colour is "dark, brownish red".  
Dimensions = 6.03mm (L) x 5.83mm (W) x 3.56mm (D-estimated)  
Total Weight = 0.89ct (estimated - see NOTE below).

Total Item Weight = 12.36 grams, Total Gemstone Weight = 0.89ct, Total Metal Weight = 12.18 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weights of the gemstone are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstone require removal from the settings. The below replacement figure is based upon crafting a similar bracelet employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
