Linkage of solid construction.

Small 'parrot' style clasp attached.

Paddle style end link sections.

Polished finish.

Stamped 'illegible' (on bracelet), '750' (on clasp).

Acid tested as 18 carat gold.

Bracelet dimensions = 18.50cm (length including clasp) x 4.85mm to 5.00mm (width).

Total Item Weight = 12.24 grams.
