### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, 18ct yellow gold and 18ct white gold and rhodium plated, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, wide, low half round band of 4.10mm width (at base) x 1.17mm depth, with open back settings, and curved underrail.

Feature five round white gold top plates, spanning across the top of the band, each housing nine round brilliant cut and single cut diamonds, largest to the centre, claw set. To the top and bottom is one row of twenty round brilliant and single cut diamonds, claw set. The settings are secured between tapering shoulders, of the plain and polished yellow gold band. Rhodium plating to the diamond rows.

Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Ring size: S 1/2.

The ring contains:

Five claw set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "H to I" (mixed).

Dimensions (average) = 2.10mm(Dia) x 1.28mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.18ct (estimated - see NOTE below)

Eighty claw set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "H to K" (mixed).

Dimensions (average) = 1.21mm(Dia) x 0.74mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.64ct (estimated - see NOTE below)

Total Item Weight = 7.90 grams Total Gemstone Weight = 0.82ct Total Metal Weight = 7.74 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
