Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and rhodium plated, 'three stone' style ring, of cast construction.

Plain, narrow, low half round band of 1.95mm width (at base) x 1.09mm depth, with open back settings, and a curved underrail.

Feature central four claw setting, housing one Princess cut diamond, claw set. Either side of the central setting, is one shared claw setting, each housing one Princess cut diamond, claw set. The settings are secured between the extended and pointed shoulders, of the plain and polished band. Rhodium plating to the setting area.

Polished finish.

Stamped '18ct' - acid tested as 18 carat gold.

Ring size: N.

The ring contains:

One claw set Princess cut diamond, clarity is "Si2", colour is "I".

Dimensions = 4.24mm(L) x 4.03mm(W) x 3.16mm(D-estimated) x 3%(Girdle Thickness)

Total Weight = 0.46ct (estimated - see NOTE below)

Two claw set Princess cut diamonds, clarity is "Si", colour is "H to I" (mixed).

Dimensions (average) = 3.24mm(L) x 3.24mm(W) x 2.53mm(D-estimated) x 7%(Girdle Thickness)

Total Weight = 0.36ct (estimated - see NOTE below)

Total Item Weight = 4.38 grams Total Gemstone Weight = 0.82ct Total Metal Weight = 4.22 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
