Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and rhodium plated, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 2.30mm width (at base) X 1.16mm, with a hollow top and shoulders, open back settings, and a curved underrail.

Feature pear shaped top plate, housing one central illusion setting, housing one round brilliant cut diamond, illusion set. Surrounding is two rows of round brilliant cut diamonds, and one row of alternating round brilliant cut and baguette cut and tapered baguette cut diamonds, claw set. The top plate is supported with a decorative gallery, and is secured between the extended and square shoulders, of the plain and polished band. Each of the shoulders houses one inner row of tapered baguette cut and baguette cut diamonds, and two outer rows of round brilliant cut diamonds, channel and claw set. There are a total of sixty-one round brilliant cut diamonds, and forty-two baguette cut and tapered baguette cut diamonds. Rhodium plating to the diamond setting areas.



Polished finish, Stamped '9K 2.00CT' - acid tested as 9 carat gold. Ring size: L.

The ring contains:

Sixty One illusion and claw set round brilliant cut diamonds, clarity is "P2 & P3" (mixed), colour is "G to I" (mixed).

Dimensions = 1.60mm(Dia) x 0.98mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.83mm(Dia) x 1.73mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 1.16ct (estimated - see NOTE below)

Forty Two claw and channel set baguette cut and tapered baguette cut diamonds, clarity is "Vs & Si & P1" (mixed), colour is "G to H" (mixed).

Dimensions (average) = 1.91mm(L) x 1.31mm(W) x 0.96mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.84ct (estimated - see NOTE below)

Total Item Weight = 5.57 grams Total Gemstone Weight = 2.00ct Total Metal Weight = 5.17 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
