## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, hand-assembled, 9ct yellow gold, diamond set, bracelet.

Feature double 'curb' link with round-shape 'belcher' bracelet design.

To each end is a rectangular 'box' linkage, each bead set with ten round brilliant cut diamonds.

A small deluxe Italian 'bolt' ring style clasp is fitted.

Polished finish.

Stamped '9ct & illegible stamp' (on bracelet), '9ct' (on each belcher link).

Acid tested as 9 carat gold.

Bracelet dimensions = 19.20cm (length including clasp) x 8.70mm (ave. width).

The bracelet contains:

Twenty bead set round brilliant cut diamonds, clarity 'Si' (mixed), colour 'H to J' (mixed).

Dimensions = 1.05mm(Dia) x 0.65mm(D-estimated) x 2%(Girdle Thickness)

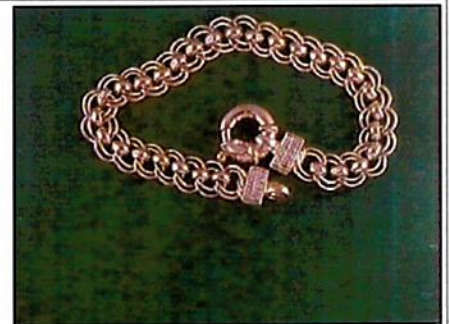
Total Weight = 0.10ct (estimated - see NOTE below)

Total Item Weight = 21.78 grams

Total Gemstone Weight = 0.10ct

Total Metal Weight = 21.76 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar bracelet employing similar materials and techniques being for a retail insurance purpose only.
