Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, gem set, multistone ring, of handmade construction.

Plain, narrow, high half round band of 1.83mm width (at base) x 1.41mm depth, with open back settings, and a curved underrail.

Feature one row of four white gold cushion shaped settings, spanning across the top of the band. Each of the settings houses one round brilliant cut or old cut diamond, graduating in size, claw set. The settings are secured to the underrail, and in between the extended and pointed 'ramp' style shoulders, of the plain and polished yellow gold band.

Polished finish.

Stamped '18CT PALAD' - acid tested as 18 carat gold.

Ring size: K.

The ring contains:

Four claw set round brilliant cut and old cut diamonds, clarity is "Si & P1" (mixed), colour is "G to I" (mixed).

Dimensions = 2.70mm(L) x 2.70mm(W) x 1.65mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.20mm(L) x 3.20mm(W) x 1.95mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.38ct (estimated - see NOTE below)

Total Item Weight = 3.04 grams

Total Gemstone Weight = 0.38ct

Total Metal Weight = 2.96 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
