Valuation for Traditional Retail Insurance Replacement

Item 1

One pair of, 9ct yellow gold and rhodium plated, gem set, hinged 'hoop' style earrings, of hand-assembled construction.

Feature the front panel houses one row of three round emeralds, individually alternating with two round brilliant cut diamonds, claw set. The earrings are finished with post and clip attachments.

Earring dimensions = 14.00mm (ave. length) x 15.00mm (ave. width) x 2.52mm (ave. depth).

Polished finish.

Stamped '375 JP88' - acid tested as 9 carat gold.

The earrings contain:

Four claw set round brilliant cut diamonds, clarity is "Si", colour is "light brown tint".

Dimensions = 2.10mm - 2.15mm(Dia) x 1.28mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.14ct (estimated - see NOTE below)

Six claw set round natural emeralds, colour is "green".

Dimensions = 2.40mm - 2.45mm (Dia) x 1.46mm(D-estimated)

Total Weight = 0.30ct (estimated - see NOTE below)

Total Item Weight = 2.48 grams Total Gemstone Weight = 0.44ct Total Metal Weight = 2.39 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pair of earrings employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
