Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's, 2pce ring set, hand-assembled raised, 9ct white gold & diamond set, multistone rings. Plain, narrow, low half round, tapered bands, measure a combined basal width 3.13mm x 0.78mm depth, with curved underrail.

Feature, "2pce ring set". Comprising, cluster style ring with shoulder stones, claw & bead set (mixed), A contured fitted band, with a single row across the top of the band, bead set.

Polished finish, unstamped - acid tested as 9 carat gold. Finger size = V1/2.



The ring set contains;

Seven claw set round brilliant cut diamonds, clarity is "P2 & P3"(mixed), colour is "G to H"(mixed), medium cut quality.

Dimensions = 1.70mm (average diameter) x 1.04mm (D-estimated) (smallest)

Dimensions = 1.85mm (average diameter) x 1.13mm (D-estimated) (largest)

Total Weight = 0.14ct (estimated - see NOTE below).

Twenty Eight bead set round brilliant cut diamonds, clarity is "P2 & P3"(mixed), colour is "G to H"(mixed), medium cut quality.

Dimensions = 0.89mm (average diameter) x 0.54mm (D-estimated) (smallest)

Dimensions = 1.17mm (average diameter) x 0.71mm (D-estimated) (largest)

Total Weight = 0.17ct (estimated - see NOTE below).

Total Item Weight = 4.21 grams, Total Gemstone Weight = 0.30ct, Total Metal Weight = 4.15 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstone require removal from the settings. The below replacement figure is based upon crafting a similar 2pce ring set, employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the iter and will not be indicative of the resale value of the item.
