### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, 18ct yellow gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.88mm width (at base) x 0.90mm depth, with open back settings, and a curved underrail.

Feature central four claw setting, housing one natural ruby, claw set. Surrounding is one row of twenty-two round brilliant cut diamonds, claw set. The top plate is secured to the extended and pointed 'ramp' style shoulders, of the plain and polished band.

Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Ring size: N 1/2.

The ring contains:

One claw set oval shaped natural ruby, colour is "red".

Dimensions = 9.16mm(L) x 6.33mm(W) x 3.86mm(D-estimated)

Total Weight = 1.94ct (estimated - see NOTE below)

Twenty Two claw set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "I to J" (mixed).

Dimensions (average) = 1.55mm(Dia) x 0.95mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.35ct (estimated - see NOTE below)

Total Item Weight = 3.46 grams Total Gemstone Weight = 2.29ct Total Metal Weight = 3.00 grams (estimated)

NOTE: The central ruby has many internal surface reaching fractures, and a significant chip to the girdle, and has been priced accordingly. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
