Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, gem set, multistone ring, of handmade construction.

Plain, narrow, low half round band of 1.97mm x 0.65mm depth. with open back settings, and a curved underrail.

Feature 'vintage' style ring, with five decorative shared claw settings, spanning across the top of the band. Each setting houses one old cut diamond, graduating in size, largest to the centre, claw set. The setting are secured between the shoulders of the plain and polished band.

Polished finish.

Stamped 'HUTTONS bird motif 18 F X' - acid tested as 18 carat gold.

Ring size: Q.

The ring contains:

One claw set old cut diamond, clarity is "P2", colour is "H".

Dimensions = 2.58mm(L) x 2.32mm(W) x 1.42mm(D-estimated)

Total Weight = 0.06ct (estimated - see NOTE below)

Four claw set old cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "G to I" (mixed).

Dimensions = 2.35mm(L) x 2.35mm(W) x 1.43mm(D-estimated) (smallest)

Dimensions = 2.63mm(L) x 2.63mm(W) x 1.60mm(D-estimated) (largest)

Total Weight = 0.25ct (estimated - see NOTE below)

Total Item Weight = 2.85 grams Total Gemstone Weight = 0.31ct Total Metal Weight = 2.79 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
