Valuation for Traditional Retail Insurance Replacement

Item 1

One, 10ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 1.85mm width (at base) x 0.88mm depth, with a hollow top and shoulders, open back settings, and a decorative pierced underrail.

Feature one central row of eleven round brilliant cut diamonds, channel set. There are two outer rows of fifteen round brilliant cut diamonds, claw set. All of the diamonds, graduate in size, largest to the centre. The settings are secured between tapering shoulders, of the plain and polished band.



Polished finish. Stamped '10K MHJ 00 TDW' - acid tested as approximately 10 carat gold. Ring size: S 1/2.

The ring contains:

Eleven channel set round brilliant cut diamonds, clarity is "P2 & P3" (mixed), colour is "H to I" (mixed).

Dimensions = 2.40mm(Dia) x 1.46mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.60mm(Dia) x 1.59mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.61ct (estimated - see NOTE below)

Thirty claw set round brilliant cut diamonds, clarity is "P2 & P3" (mixed), colour is "H to I" (mixed).

Dimensions = 1.40mm(Dia) x 0.85mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.60mm(Dia) x 0.98mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.39ct (estimated - see NOTE below)

Total Item Weight = 4.67 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 4.47 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
