Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, gme set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, flat, tapered band of 3.24mm width (at base) X 0.91mm depth, with open back settings.

Feature central white gold multi-claw setting, housing one pear shaped natural aquamarine, claw set. Surrounding is one row of nineteen single cut diamonds, claw set. The top plate is supported with an open wire base, and is secured to the top of the plain and polished yellow gold band. The setting is embellished with rectangle shoulder plates.

Polished finish.

Stamped 'X 18CT PLAT X' - acid tested as 18 carat gold.

Ring size: R.

The ring contains:

One claw set pear shaped natural aquamarine, colour is "blue".

Dimensions = 11.28mm(L) x 6.88mm(W) x 4.2mm(D-estimated)

Total Weight = 1.57ct (estimated - see NOTE below)

Nineteen claw set single cut diamonds, clarity is "Si & P1" (mixed), colour is "H to J" (mixed).

Dimensions (average) = 1.50mm (diameter)

Total Weight = 0.29ct (estimated - see NOTE below)

Total Item Weight = 7.19 grams Total Gemstone Weight = 1.86ct Total Metal Weight = 6.82 grams (estimated)

NOTE: The aquamarine has significant abrasion to the crown facets. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
