Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand finished, raised 14ct rose gold & gemset, cluster ring. Plain, narrow, low half round, tapered band, measures 1.90mm width (at base) x 1.25mm depth, with curved underrail, open back setting, underneath.

Feature: "cluster style" ring design. Comprising, a raised four claw setting to centre, houses one oval-shaped faceted natural tanzanite, claw set. Drops to a wire basket surround, containing sixteen round, faceted, natural peridot gemstones, claw set. The extended shoulders, sweep up to the top, from both sides.

Polished finish, stamped "585" - acid tested as 14 carat gold. Finger size = O1/2.

The ring contains;

One claw set oval-shaped, faceted, natural tanzanite, colour is "dark opaque material, bluish violet".

Dimensions = 15.18mm (L) x 11.43mm (W) x 8.73mm (D-estimated) x 10.5%(Bulge)

Total Weight = 13.34ct (estimated - see NOTE below).

Sixteen claw set round natural peridot, colour is "very light yellowish green".

Dimensions = 2.90mm (average diameter) x 1.77mm (D-estimated) (smallest)

Dimensions = 3.00mm (average diameter) x 1.83mm (D-estimated) (largest)

Total Weight = 1.58ct (estimated - see NOTE below).

Total Item Weight = 7.46 grams, Total Gemstone Weight = 14.92ct, Total Metal Weight = 4.48 grams (estimated)

NOTE: Limited gemmological testing, inset. The Tanzanite is heavily, included, surface reaching internal fracture external chips & wear visible. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
