## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 18ct yellow gold and 18ct white gold, gem set, 'cluster' style ring, of hand-assembled

Plain, narrow, low half round band of 1.93mm width (at base) x 1.28mm depth, with open back settings, and curved underrail.

Feature central white gold four claw set, housing one round brilliant cut diamond, claw set. Surrounding is floating row of twelve round brilliant cut diamonds, claw set. The top plate is secured between the upswept shoulders, of the plain and polished yellow gold band. The gallery is embellished on each side with a a semi-circle row of seven round brilliant cut diamonds, claw set.



Polished finish.

Stamped '750 T' - acid tested as 18 carat gold.

Ring size: M 1/2.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si1", colour is "H".

Dimensions = 3.89mm(L) x 3.87mm(W) x 2.36mm(D-estimated) x 2.5%(Girdle Thickness)

Total Weight = 0.22ct (estimated - see NOTE below)

Twenty Six claw set round brilliant cut diamonds, clarity is "Si", colour is "H".

Dimensions = 1.09mm(Dia) x 0.66mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.81mm(Dia) x 1.10mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.39ct (estimated - see NOTE below)

Total Item Weight = 4.48 grams Total Gemstone Weight = 0.61ct Total Metal Weight = 4.36 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
