Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, 'dress' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 1.81mm width (at base) x 1.07mm depth, with a curved underrail.

Feature central four claw setting, housing one emerald cut natural sapphire, claw set. The setting is secured to the decorative curled underrail, and in between the extended and square shoulders, of the plain and polished band.

Polished finish.

Stamped '18c' - acid tested as 18 carat gold.

Ring size: L.

The ring contains:

One claw set emerald cut natural sapphire, colour is "blue".

Dimensions = 5.18mm(L) x 4.53mm(W) x 3.39mm(D-estimated)

Total Weight = 0.80ct (estimated - see NOTE below)

Total Item Weight = 3.88 grams

Total Gemstone Weight = 0.80ct

Total Metal Weight = 3.72 grams (estimated)

NOTE: There is significant abrasion to the crown facets of the centre stone. Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
