Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and rhodium plated, gem set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round band of 2.51mm width (at base) x 0.94mm depth, with open back settings, and a curved underrail.

Feature three square top plates, spanning across the top of the band, graduating in size, largest to the centre. Each setting houses four Princess cut diamonds, invisibly set. The settings are secured between the extended and pointed shoulders, of the plain and polished band. Rhodium plating to the setting areas.



Polished finish.

Stamped '750 CG' - acid tested as 18 carat gold.

Ring size: O.

The ring contains:

Four invisibly set Princess cut diamonds, clarity is "Vs & Si" (mixed), colour is "I to J" (mixed).

Dimensions (average) = 2.20mm(L) x 2.20mm(W) x 1.56mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.28ct (estimated - see NOTE below)

Eight invisibly set Princess cut diamonds, clarity is "Vs & Si" (mixed), colour is "I to J" (mixed).

Dimensions (average) = 1.70mm(L) x 1.70mm(W) x 1.21mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.22ct (estimated - see NOTE below)

Total Item Weight = 4.57 grams Total Gemstone Weight = 0.50ct Total Metal Weight = 4.47 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
