Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, 'dress' style ring, of cast construction.

Plain, narrow, low half round band of 3.79mm width (at base) x 0.99mm depth, with a curved underrail.

Feature central four claw setting, housing one emerald cut natural aquamarine, claw set. The setting is secured to the underrail, and in between the 'split' style shoulders, of the plain and polished band. The setting, shoulders and underrail houses a total of one hundred and four round brilliant cut diamonds, claw set. The shoulders extend out from the plain and polished band.

Polished finish.

Stamped 'K 18K' - acid tested as 18 carat gold.

Ring size: L 1/2.

The ring contains:

One claw set emerald cut natural aquamarine, colour is "blue".

Dimensions = 10.77mm(L) x 8.88mm(W) x 7.53mm(D-estimated)

Total Weight = 4.90ct (estimated - see NOTE below)

One Hundred And Four claw set round brilliant cut diamonds, clarity is "Si", colour is "G to H" (mixed).

Dimensions = 1.21mm(Dia) x 0.74mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.31mm(Dia) x 0.80mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.83ct (estimated - see NOTE below)

Total Item Weight = 11.70 grams Total Gemstone Weight = 5.73ct Total Metal Weight = 10.55 grams (estimated)
