Valuation for Traditional Retail Insurance Replacement

Item 1

One, silver, gem set, 'solitaire' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 1.55mm width (at base) x 1.26mm depth, with a curved underrail.

Feature central decorative six claw setting, housing one synthetic moissanite, claw set. The setting is secured to the underrail, and in between the extended and pointed shoulders, of the plain and polished band.

Polished finish.

Incorrectly stamped 'PT950 D1.00CT 100020738' - acid tested and x-rayed as silver.

Ring size: Q 1/2.

The ring contains:

One claw set round synthetic moissanite, colour is "colourless".

Dimensions = 6.52mm(Dia) x 3.98mm(D-estimated)

Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 1.62 grams

Total Gemstone Weight = 1.00ct

Total Metal Weight = 1.42 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
